Stellar Participation Fee & Activation Agreement

New Member Application

This agreement is made on ______ between the Subscriber and Stellar Multiple Listing Service.

The access issued to each Participant or Subscriber is unique and strictly confidential to that person. Authorized Participant,/Subscriber agrees that should a disclosure of account information result in access by an unauthorized third party, Authorized Participant,/Subscriber may be subject to penalties as follows:

- 1. A fine of up to \$15,000 (as determined by the Board of Directors) for each occurrence will be assessed against any Participant/Subscriber found to have allowed or provided access to the MLS system by an unauthorized person.
