



CERTIFICATION FOR FLORIDA REALTORS® EMERITUS STATUS

Pursuant to Florida Realtors® Bylaws Article II Membership, a REALTOR® member who does not qualify for NAR Realtor® Emeritus but has held REALTOR® or REALTOR®-ASSOCIATE membership in Florida Realtors® for a cumulative period of forty (40) years and who has completed at least one (1) year of service as a Florida Realtors® officer, director, committee member or Presidential Advisory Group appointee, shall be designated as a Florida Realtors® Emeritus upon submission of this application and approval by Florida Realtors®.

Members designated as Realtor® Emeritus by NAR **and/or** Florida Realtors® Emeritus shall be exempt from Florida Realtors® dues and assessments. Florida Realtors® Emeritus members who are not designated by NAR as a Realtor® Emeritus must continue to pay NAR dues and complete NAR's required Code of Ethics Training.

ADDITIONAL INFORMATION

- Florida Realtors® Emeritus members are **not exempt** from the biennial NAR Code of Ethics Training course.
- Supporting documents are optional at time of application, however, Florida Realtors® staff reserves the right to request such documents, if necessary.
(*e.g. membership certificates, board bulletins or DBPR licensure history report, etc.*)
- Upon approval by Florida Realtors® no further payment of dues & assessment is necessary to Florida Realtors®.
- The dues waiver takes effect the next dues calendar year. **Applications received after 12/31 will be processed for the next calendar year.**
- **Waiver of dues by the local level is at the discretion of the local board.**
- After approval, each Florida Realtors® Emeritus member will receive a congratulatory letter and certificate. This will be sent to the member's primary board to present to the member.
